AUDITION NOTICE

Dear Parents and Guardians,

The audition for the Missoula Children's Theatre production of **Rumpelstiltskin** will be held on **August 15, 2016 at 10:00 a.m.** at **The Crystal Theatre**. There are roles for those students entering 1st grade this fall through 12th grade this fall. Approximately 50-60 local area (Iron County, Florence County, Dickenson County, and surrounding counties) students will be cast to appear in the show with the MCT Tour Actor/Director. **There is no guarantee that everyone who auditions will be cast in the play.**

Students wishing to audition must arrive by 10:00 am and stay for the entire two-hour session. The first rehearsal begins at 12:30 pm on Monday, after the audition. It is possible that only some may be required to attend. All should come prepared stay for the afternoon rehearsal and bring a sack lunch.

This is a group audition—**no advance preparation is necessary**, but a smile never hurts. Students should just be ready to come and have a good time!

Rehearsals will be conducted every day from 10:00 to Noon and 12:30 to 2:30 in the Theatre and Stage Left at the Crystal Theatre. Although not all cast members will be needed at every session, those auditioning must have a clear schedule for the entire week and if selected, be able to attend all rehearsals required for their role. A detailed rehearsal schedule will be distributed at the conclusion of the audition. Cast members scheduled for the full 4½ hours of rehearsal and take a ½ hour lunch, please bring a bag lunch.

The performances will be held on Friday Aug. 19 at 7:00 and Saturday Aug. 20 at 2:00 and will be presented at the Crystal Theatre. The students in the cast will be called for dress rehearsal before the performance that day. All those cast must be available for all scheduled performances.
